1. TOURNAMENT DATE & LOCATION

- a). Date: **December 5, 2020 – 12:00 p.m. And 3:00 p.m.**
- b). Location: **Reno National Bowling Stadium**

2. FORMAT

- a). This is a singles tournament.
- b). All bowlers will bowl 3 games with total pinfall plus handicap determining the winners.
- c). Men & Women will compete in the same division.

d). Prize Money Distribution:

1 st Place	-	\$1,000.00
2 nd Place	-	\$750.00
3 rd Place	-	\$500.00
4 th Place	-	\$250.00
5 th Place through 15 th Place	-	\$125.00
16 th Place through 30 th Place	-	\$75.00

**There will optional
Scratch & Handicap
Brackets Side Pot
On-Site at the Finals.**

31st Place through 130th Place Based on number of entries.

- e). Total Prize Fund to be paid out will be **\$10,000.00 based on 500 entries to the finals.**
Bowlers under the age of 21 years or bowlers not present will be sent checks within 7 days of bowling.

3. HANDICAP

- a). Handicap for both men and women will be 100% of 220.

4. AVERAGE FOR THE SINGLES TOURNAMENT

The Highest of the Following

- a). The highest verifiable 2018-2019 average of 21 or more games.
 - b). The highest verifiable 2019-2020 average of 21 or more games.
- If None of the above:
- c). Highest 2020 Summer League average as of August 31, 2020.
 - d). Current league average 21 or more games as of November 15, 2020.
 - e). Bowlers without one of the above averages (rule-a,b, or c, will bowl scratch)
Average verification must accompany entry. This is the bowler's responsibility and there will be no pay-off without verification.

5. RE-RATE

Bowlers who have won, or expect to win cash or merchandise prizes of \$600.00 or more in a single event including all events in any tournament within the last 12 month period (December 5, 2019-December 5, 2020) must provide the tournament director the following information:

- a). Name of tournament in which he/she has been paid or qualified for such a prize.
- b). The amount of the prize.
- c). The actual score(s) bowled to qualify for the prize.
- d). The prize position.

A bowler must report if he/she has an accumulated average in 21 or more games of tournament play in the previous 12 months that exceeded their entering average by 10 or more pins. Any bowler who has ever been re-rated by any bowling center, tournament, or association must inform the tournament director of his/her re-rating. Any bowler who has refused a re-rate, or has been disqualified by any tournament, must report this before bowling, and will be subject to re-rating or denial of entry in this tournament. These **MUST** be reported to the tournament officials at the time of entry in this tournament. Failure to do this could cause disqualification in this event

6. ADMINISTRATION

This tournament shall be conducted under the supervision of Nor Cal Bowling Centers.
