# Northern California Bowling Center's Nugget Casino Resort Jubilee State Finals Tournament Rules



**Team Entry Fee:** \$156.00 per team

**State Finals will be conducted at Wild Island Coconut Bowl located at 1855 E Lincoln Way, Sparks, NV 89434 October 1-3 & 8-10, 2021.**



**Eligibility:** Bowlers with a verifiable league average in a USBC Certified or Non-Certified League will be eligible to bowl. Teams shall consist of Four (4) members any combination men/women. Team Entering Average may not exceed 850. Three games will be bowled on the same pair of lanes.

**Multiple Participation Rule:** Bowlers may bowl more than once, but the team roster may not exceed more than two (2) of the same bowlers. Teams must have at least two (2) new bowlers. Teams using a substitute will be subject to this rule.

**Averages for the State Finals:** Bowlers will use the **HIGHEST** of the following (USBC Certified and Non-Certified League averages will be used for this tournament):

- ⇒ **Highest Verifiable** of the last 3 years including Summer (2018-19, 2019-2020 & 2020-21)
- ⇒ **Highest Composite** avg of 21 games or more for the last 3 years
- ⇒ **Bowlers Without One Of The Above Averages** - Bowlers entering the league without a verifiable average will enter with a 220 average.

**Bowlers Must Provide Average Verification in the form of Bowl.com report and/or League Standing Sheet (especially for non-certified leagues) Along with Completed Entry Forms. Failure to submit all forms of average verification will result in bowler disqualification.**

**Handicap:** Handicap will be 80% of the difference of the team's average from 850.

**Substitutes:** A team requiring a substitute bowler for the Nor Cal BC Nugget Resort Jubilee State Finals Tournament must abide by the following:

1. Substitute may not bowl on a team if they have or are scheduled to bowl on another team which would create a roster with more than two (2) of the same bowlers for the this team.
2. Substitute's entering average may not cause the team's entering average to exceed 850.

**Ratio & Prize Money:** Prize money will be paid on a basis of one for every four teams bowling in the State Finals. Prize money will be paid out 100%. Total pinfall plus handicap will determine standings on prize list.

**Reporting of Prize Winnings:** Bowlers who have won \$600.00 or more in any one tournament in the past 24 months (from date of entry) or an accumulation of \$1000.00 or more in the last 12 months must report those winnings. Nor Cal BC will provide a winnings report and it must be filled out completely and turned in at least 1 hour prior to bowling. Failure to comply with these rules could cause disqualification from this event.

**Re-Rates:** All prior re-rates & re-rate refusals will apply to this tournament. Tournament organizers reserve the right to re-rate any contestant for any reason, including, but not limited to, tournament results and non-certified league averages. Any re-rate shall become effective for all qualifying play occurring after date of re-rate.

**Optional "Alibi Side Doubles":** A best 2 out of 3 doubles will be conducted during the team event at the finals. \$10.00 per doubles team. You will use the same scores rolled in the Nor Cal BC Nugget Resort Jubilee Finals but will drop your low game. The average you use is the same as the Jubilee average. Handicap will be given based on 80% of 440. You may pair up with any and all members of your team only. Prize money will be paid to 1 in every 10 doubles teams. There is no limit to the number of times that you may cash.

**Tournament Dates: October 1-3 & 8-10, 2021**

**For Scheduling Consideration:** Entries received by September 1, 2021, will have priority scheduling considerations. (Entries will be accepted up to and including the start of the final squad on October 10, 2021).
