

Northern California Bowling Center's 2023 Jubilee State Finals Tournament Rules



Team Entry Fee: \$200.00 per team

State Finals will be conducted at Reno's National Bowling Stadium located at 300 N Center Street, Reno, NV 89501 September 29 - October 1, 2023



Eligibility: Teams shall consist of Four (4) members any combination men/women and must have bowled in a 2023 Nor Cal Bowling Center Jubilee League. Teams whose individual averages combined together upon entering at the league level may not exceed 850. Any team found to have entered a Jubilee League in excess of 850 maximum entering average will not be allowed to bowl in the Nor Cal BC State Finals. Three games will be bowled on the same pair of lanes.

Multiple Participation Rule: Teams may participate in the tournament with as many leagues as they qualify from. Teams who constitute a duplicate team (3 or more of the same bowlers) may cash more than once in the prize list, providing they bowled as the original team in more than one Nor Cal Jubilee league.

Averages for the State Finals: Bowlers will use the **HIGHEST** of the following (USBC Certified and Non-Certified League averages will be used for this tournament):

- Ending 2023 Jubilee League average(12 games or more)
- Highest Verifiable of the last 3 years including Summer (2020-2021, 2021-2022 & 2022-2023)
- ⇒ **Highest Composite** avg of 21 games or more for the last 3 years
- Any bowler not having bowled 12 games or more will be ineligible for the Jubilee Finals.

Bowling Centers Must Provide Final Standing Sheets Along with Completed Entry Forms

Handicap: Handicap will be 80% of the difference of the team's average from 850.

Substitutes: A team requiring a substitute bowler for the Nor Cal Bowling Centers Jubilee State Finals Tournament must abide by the following:

- 1. Select any Jubilee League Bowler who has 12 games or more in a Jubilee League.
- 2. Whose Entering Jubilee League Average, when added to those of the remaining team members entering averages will not cause the total of the four bowlers to exceed the 850 team maximum.
- 3. Emergency substitutes may be allowed at the discretion of the Tournament Director.

Ratio & Prize Money: Prize money will be paid on a basis of one for every four teams bowling in the State Finals. Prize money will be paid out 100%. Total pinfall plus handicap will determine standings on prize list.

Reporting of Prize Winnings: Bowlers who have won \$600.00 or more in any one tournament in the past 24 months (from date of entry) or an accumulation of \$1000.00 or more in the last 12 months must report those winnings. Nor Cal BC will provide a winnings report and it must be filled out completely and turned in at least 1 hour prior to bowling. Failure to comply with these rules could cause disqualification from this event.

Re-Rates: All prior re-rates & re-rate refusals will apply to this tournament. Tournament organizers reserve the right to re-rate any contestant for any reason, including, but not limited to, tournament results and non-certified league averages. Any re-rate shall become effective for all qualifying play occurring after date of re-rate.

Optional "Alibi Side Doubles": A best 2 out of 3 doubles will be conducted during the team event at the finals. \$10.00 per doubles team. You will use the same scores rolled in the Nor Cal Bowling Centers Jubilee Finals but will drop your low game. The average you use is the same as the Jubilee average. Handicap will be given based on 80% of 440. You may pair up with any and all members of your team only. Prize money will be paid to 1 in every 10 doubles teams. There is no limit to the number of times that you may cash.

Tournament Dates: September 29 - October 1, 2023

For Scheduling Consideration: Entries received by September 1, 2023, will have priority scheduling considerations. (Entries will be accepted up to and including the start of the final squad on October 1, 2023).
